



**GUEST AGREEMENT AND CREDIT CARD AUTHORIZATION CONCERNING PETS**

For the privilege of bringing my pet(s) to stay with me in Cabin #\_\_\_\_\_ at {name of Ohio Lodge inserted here} (the Resort), I the undersigned, agree to the following:

I agree to bring no more than two pets to the Resort. I understand that no pets other than dogs or cats are permitted at the resort. I understand that all pets must be registered at check-in. I understand that unregistered pets are subject to an additional \$50.00 charge. I am bringing the following described dog(s) or cat(s) to the resort.

I agree to pay an additional charge of \$15.00 per night or \$72.00 per week per pet for the privilege of having my pet(s) at the resort. I agree that my pet(s) may only be in the cabin area of the resort and may not enter any cabins, rooms, facilities, buildings, or structures except for my own cabin. I agree not to allow any pet(s) into my cabin other than the pet(s) described above.

I agree to keep my pet(s) on a leash in hand and under control at all times while outside. I understand that the leash must be no longer than 6 feet from hand to pet. I understand that this leash requirement is not just a resort rule, but also an Ohio Administrative Rule for this State Park (Ohio Administrative Code Section 1501:41-3-06).

I agree to keep my pet(s) from bothering others in any way while at the resort. I agree to remove my pets from the resort at the request of a resort or park representative if I do not comply with this requirement or one or more other requirements in the Agreement. I understand that Ohio Administrative Code Section 1501:41-3-08 applies to the resort and park areas and states:

If the menacing attitude of any animal under the control or supervision of any person within any area administered by the Division excites fear in other persons, or if the animal disturbs the quiet enjoyment by other persons of any area administered by the Division by incessant barking, whining, howling, crying or other incessant sharp, abrupt outcries, or other means, a Park Officer may direct that the animal be removed by the owner or handler from any area administered by the Division.

I agree not to leave my pets unattended (inside or outside) at any time. I agree to keep my pets indoors overnight. I understand that if I leave my pets unattended inside the cabin, housekeeping and maintenance personnel may elect not to enter the cabin.

I agree to clean up after my pets, both indoors and outdoors. I agree to be fully responsible for any damage or injury caused by my pets at the resort including any additional cleaning or repair costs if the resort determines that damages were caused by my pets.

I agree that the resort may charge my credit card on file for any costs or charges described in this Agreement.
